If our proposed tax levy increase is greater than: \$389226 a super majority, 60%, voter approval must be met - of those voters turning out to vote  
 If the voters reject our budget then our levy must equal : \$23612596 which is a 0% increase and follows contingency budget rules  
 If we don't go to the tax cap limit by law, we compound the problem of revenue shortfall in coming years  
 We are to use our best estimates for next year's PILOTS, but must be able to document our number in an audit
